#### 1. Declarations of interest

No further declarations of interest were noted from the Trustees from matters arising or this meeting.

## 2. Ratification of the Minutes from April 2024 Trustee Meeting

The Trustees ratified the minutes from the April meeting.

3. April SGM: as set out in resolution passed at the last OGM.

The Trustees decided last week by a 4:1 majority to send out the email on the April SGM including the paragraph asking all POs to abide by the democratic decisions.

## 4. Trees: Cestrian

Works to be completed.

Cedarwood adjacent to 7 Cedarwood x 2
The Coppice adjacent to 12 The Coppice
Both these stumps need to be done urgently.
These are booked in for 16<sup>th</sup> June 2024

## Cestrian has been sent exact locations of the trees highlighted in red so the relevant TPO requirements can be requested from CWAC.

- 1 The Cobbles x 2
- 2 DPWW Chestnut opposite Clubhouse
- 3 HOL Sycamore
- 4 DPWW, Oak opposite 53
- 5 Paddock Walk, Oak adjacent to footpath
- 6 The Burrows Green, 200 year old Chestnut. Needs the canopy thinning out. Half days work.
- 7 Denehurst Park Way Green opposite Paddock Walk, 200-year-old Sycamore

### Tree work carried out by Cestrian on 23rd/24th April 2024

- 1. Fawns Leap Silver Birch Felled. Tree was dying with Ivy strangulation and was in a dangerous condition.
- 2. 30 DPWW- Birch tree thinned out as requested by PO.
- 3. The Downs Beech tree and Lime tree adjacent to Footpath @ 1 The Downs, Canopy reductions
- 4. The Dell Oak tree felled, and canopy reduction on adjacent Oak tree, boundary of field opposite 5 The Dell
- 5. The Dell- Dead stump felled on grass bank adjacent to 4 The Downs

## Stump grinding was carried out at the following;

DPWW on the green adjacent to Swimming Pool

DPWW verge at junction of HOL

Green rear of substation x 2

HOL adjacent to 67 DPWW (Needs to be Landscaped asap)

Long Acre x 2 opposite 23 Long Acre

The Coppice on verge adjacent 6 The Coppice

The Sycamore tree on the green in Long Acre adjacent to 15 Long Acre was inspected by the Tree surgeon. No further work was recommended. The canopy has been reduced 3 years ago. Only course of action would be to take the Tree out. The Tree is healthy and has a good canopy.

#### 5. Purchase of structure for bar outside area

It was agreed that the area be measured, and a suitable structure be purchased. LK to contact community groups to ask if they could offer any funds to help support towards.

#### 6. Pool training / staff to attend.

It was agreed that as many staff that can attend the course do so including the potential new starter.
